Shooting STAR: Graduate Profile

Last December, Julie B. stood before the STAR II docket that staying active with alumni and was honored as one of the first STAR program graduates. After over a year of adhering to treatment guidelines and attending courtroom sessions, Julie took on the responsibility of leading an independent and sober life.

Julie began the program in October of 2003, soon after the program started taking clients. She began to think of STAR drug court team as a "family," a group that supports clients. Upon graduation, she felt both excited and scared. She feared losing this guidance, and immersed herself in all the aftercare opportunities that STAR offered. She joined the STAR Alumni Association, and

was elected president. She says helps her stay connected to the program's support.

Today, Julie strives in all aspects of her recovery. She not only remains active in the Alumni Association, but she also diligently works as a gymnastics coach, a position that she lost temporarily because of her substance abuse. During treatment with the STAR program, Julie began working at a large coffee chain and remains "very passionate in everything" that involves her company. Julie excitedly awaits a promotion to Management in January.

Julie also focuses on her treatment, attending group and a month. The most rewarding



part of counseling is the sessions with her husband where together they "learn to grow up together." She plans to travel and focus on "achieving my personal life dreams outside of a career."

Julie thanks Judge Cosper and Mary Covington, both of whom were incredible role models, her counselor Colleen, and Suzy, her AA sponsor. Finally, she thanks her "very patient and tolerant husband. individual counseling three times Mike," for supporting her recovery.

Drug Court Support Foundation

Before STAR enrolled its first client, Emerson Unitarian Church formed a Drug Court Task Force to study and support a drug court in Harris County. After meeting with members of the drug court planning team, the Task Force incorporated the

Drug Court Support Foundation of Harris County and applied for 501c (3) non-profit status with the Internal Revenue Services.

Among the Foundation's initial directors are Dr. Maximillian Buja, Executive

STAR III Docket—Judge Cosper finds new home

In June of 2005, the STAR court proudly began a new drug court docket. Judge Caprice Cosper, of the 339th District court and formerly of the STAR II docket, took the helm of STAR III, which meets at 3PM on Wednesdays.

Access To Recovery funding is now available to all STAR clients.

Judge Brock Thomas of the 338th District Court joined the drug court team and took over the STAR II docket. Initially, STAR III was established to utilize the Access to Recovery (ATR) funding. ATR is a federal initiative to increase access to substance abuse services through independent assessment, offer participants a choice of service providers, promote partnerships with faith-based and community-based organizations, and provide an electronic voucher method of payment.

Originally, the money was only available to increase the number of Texas drug court participants. Recently, the ATR funding was made available to all STAR clients, and to date STAR has over thirty clients benefiting from the recovery support services and substance abuse treatment offered though ATR.

Like the original dockets, STAR III offers an intensive, individualized approach to supervision and treatment. Clients participate in group and individual chemical dependency counseling, attend 12-step or support groups, submit to frequent random drug testing and appear frequently before the judge.

In addition, they receive recovery support services that assist in resolving the underlying issues of their dependency and have been barriers to recovery in the past.

Stellar Support Program

In an effort to foster a supportive and preventive parenting environment, Career and Recovery Resources offers the Strengthening Families Program (SFP). All STAR Program clients attending C&R participate in this comprehensive program.

SFP is based on three skills courses: Parenting, Children's Life Skills, and Family Skills. SFP skills are not special skills designed for deficient families only, but they are designed for

Foundation-

The Task Force envisioned the Foundation as an interdenominational effort to inform other faith communities about the alternative sentencing program and to provide broadbased community support for the STAR Drug Court Program. The high-stress families who need another layer of therapy.

SFP was initially developed to prevent substance abuse by children in drug and alcoholstressed families. It draws on research and practice in many professions which have shown that by strengthening the family the risk of many adverse behaviors developing in children is greatly reduced.

Certain family risk factors addressed during the courses are conflict, low expectations, poor
