## 351st District Court's Emergency Order

March 8, 2021

In light of the Governor's Emergency Order GA-34 and the Supreme Court's Thirty-Sixth Emergency Order, the 351st District Court adopts the following policies:

FOR ANY IN-PERSON APPEARANCE, FACE MASKS ARE REQUIRED, SOCIAL DISTANCING IS REQUIRED, AND PRIOR PERMISSION IS REQUIRED AS LAID OUT IN THIS ORDER.

ANYONE WHO HAS TESTED POSITIVE FOR COVID-19 OR HAS HAD CLOSE CONTACT WITH SOMEONE WHO HAS TESTED POSITIVE IN THE PAST 14 DAYS, OR IS EXHIBITING SIGNS OR SYMPTOMS OF COVID-19 (Cough, shortness of breath, fever, fatigue, body aches, or stomach illness) SHALL NOT APPEAR IN PERSON.

## **DEFENDANTS:**

Defendants **SHALL NOT physically** appear in Court UNLESS:

- (1) They lack of access to technology;
- (2) They lack of ability to use the technology because of a physical or mental disability;
- (3) A constitutional claim that requires in-person appearances exists;
- (4) A defendant's personal identification is needed, including a fingerprint;
- (5) incarceration is a possible result of the proceedings;
- (6) their appearance is for an essential hearing as defined previously by the OCA; and/or
- (7) they are instructed to appear physically by the court.

Defendants on bond **DO NOT** need to appear remotely over Zoom UNLESS:

- •instructed to make an appearance by the court;
- not represented by counsel;
- •set for their initial appearance (first appearance in court); OR
- •defendant has pending bond conditions or violations.

## **ATTORNEYS**

Attorneys SHALL appear remotely via Zoom.
