CASE MANAGEMENT ORDER NO. 2

To comply with its mandate under Rule 13, the Court finds that it is necessary to create a system to identify all documents related to each individual case transferred or “tagged” into the Master MDL cause number. Therefore, it is hereby ORDERED that:

1. Each case shall be assigned a unique MDL Case Number. From the date of this Order, that number shall be used by all persons filing documents that relate to an individual case in the Master Cause No. 2021-41903.
2. The format of the MDL Case Number for this MDL is [MDL Case No. 5.00000] (the number 5 followed by a decimal and 5 digits, to be numbered sequentially).
3. All documents filed after the date of this Order shall include the MDL Case Number in the title of the instrument, in brackets following the title of the document. For example, “Notice of Tag-Along [MDL Case No. 5.00140].”
4. The MDL Case Number shall be assigned to each case by Defendants’ Liaison Counsel at the earliest possible time. Any person “tagging” a case into the MDL is encouraged to first contact Defendants’ Liaison Counsel and obtain an MDL Case Number and include it on the Notice of Transfer.
5. Periodically, Liaison Counsel shall file with the Court a chart, which shall include the MDL Case Number assigned to each case in the MDL. The Parties are directed to review the chart to obtain their respective MDL Case Numbers and include them on all filings.
6. Attached to this Order as Exhibit A is a chart containing MDL Case Numbers for all cases part of this MDL as of the date of this Order.

This Order will remain in effect unless or until amended, altered, modified, or vacated by the Court.
