## Harris County State District Court resets and cancellations for Friday, May 17, 2024

**May 16, 2024** — In response to the widespread power outage and weather damage affecting Harris County, and in light of the [Houston Independent School District's announcement to close](#), most of the Harris County State District Courts have made the decision to reset or cancel their dockets on May 17, 2024.

Court proceedings in these specific courts will be rescheduled to a later date and will not affect the Monday, May 20, 2024 dockets. We understand the inconvenience this may cause for individuals with scheduled court appearances or pending legal matters, and encourage you to check with your specific court for any questions or concerns.

Ancillary, warrant, and detention court will remain operational.

We appreciate the understanding and cooperation of the legal community and the public during these challenging weather conditions.
